

WHEREAS, the Board is a plaintiff in a pending muti-district litigation entitled In re JUUL Labs, Inc. (the "JUUL litigation"); and

WHEREAS, the Board's legal counsel in the JUUL Litigation has apprised the Board of a proposed settlement of the pending litigation, including the general terms and conditions of the proposed settlement; and

WHEREAS, the Board's legal counsel recommends the Board approve the proposed settlement, subject to final legal review and approval; and

WHEREAS, the Board finds it is in the District's interest to proceed with the proposed settlement of the JUUL Litigation.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Green Local Schools (Smithville, Ohio- Wayne County) as follows:

- The Board hereby authorizes its legal counsel, in the JUUL Litigation, Frantz Law Group, to consent on behalf of the Board to the proposed settlement of said litigation with Altria Group, Inc., Phillip Morris USA, Inc. and related companies specified in the settlement and release agreement, subject to legal counsel's final review and approval of the terms and conditions of the settlement agreement as being consistent with the terms and conditions legal counsel previously discussed with the Board.
- 2. This resolution shall take effect immediately.
- 3. The Board finds that this resolution was approved at a regular meeting open to the public in accordance with the provisions of Section 122.21 of the Ohio Revised Code.

SCHOOL RESOURCE OFFICER AGREEMENT

This Agreement is made this 23rd day of October, 2023, by and between **GREEN LOCAL SCHOOL DISTRICT**, **SMITHVILLE**, **OHIO** (hereinafter "School District"), and **THE VILLAGE OF SMITHVILLE** (hereinafter the "Village").

WITNESSETH:

WHEREAS, the School District has determined that it will benefit from the implementation of a School Resource Officer Program ("Program");

WHEREAS, the Village agrees to provide the School District a School Resource Officer Program in the School District; and

WHEREAS, the School District and the Village desire to set forth in this Agreement the specific terms and conditions of the services to be performed and provided by one (1) School Resource Officer ("SRO") in the School District;

NOW, THEREFORE, THE PARTIES MUTUALLY AGREE AS FOLLOWS:

1. **Cost of the Program.** The School District shall pay to the Village the sum of One Hundred Seventy Three Thousand Eighty Six Dollars (\$173,086.00) for 3 years of service. The 2023-2024 school year is prorated to reflect the change in full time SRO coverage.

2023-2024-60 days part-time at \$28,400 annually = \$9,466

2023-2024 - 120 days full time at \$60,000 annually = \$39,996

2024-2025 – 180 days full time at \$61,200

2025-2026 - 180 days full time at \$62,424

The SRO shall be paid by the Village of Smithville as an employee of the Police Department. The Village shall submit an invoice for full amount of \$173,086, due no later than January 1,2024. The School District will have no responsibility for payment directly to the SRO or any withholding or benefits. The Village will maintain insurance for the SRO.

2. **The Program.** The Program may consist of the assignment of one (1) full-time SRO for the School District from the commencement date of this Agreement through the last day of school, as determined by the School District calendar. The SRO shall be assigned duties as provided for herein.

3. Employment of SRO.

A. The SRO shall be an employee of the Village and its Police Department and shall be subject to the administration, supervision and control of the Police Department. The SRO shall be subject to all personnel policies and practices of the Police Department except as such policies or practices may be modified by the terms and

- conditions of this Agreement. The Village, in its sole discretion, shall have the power and authority to hire, discharge, and discipline the SRO.
- B. A joint committee composed of the Chief of the Police Department and a representative of the School District shall convene as requested by either party to review the SRO officer and the Program. If the School District is dissatisfied with the SRO, then the Police Department may make a personnel change.

3. **Duty Hours.**

- A. SRO duty hours shall be determined by the provisions of the labor agreement between the Village and the School District. Whenever possible, it is the intent of the parties that the SROs' duty hours shall be not more than eight (8) hours per school day. The School District and the Village further agree that the Program shall consist of no more than forty (40) duty hours per week. A full day of service is 8 hours from approximately 7:20 am 3:20 pm.
- B. It is understood and agreed that the SRO may have emergency duties that preclude him or her from being at the School District during normally scheduled hours. In these circumstances, the Police Department shall provide as much advance notice to the School District as possible. During a schedule absence, the Police Department will provide a substitute officer.
- 4. **Term of Agreement.** The initial term of this Agreement shall commence on October 23, 2023 and ending on the last school day of the 2025-2026 school year.

5. **Duties of SRO.**

The SROs' duties shall include, but not be limited to, the following:

- A. To be a visible, active law enforcement figure on campus dealing with law enforcement matters.
- B. To assist the School District in providing a safe environment as to law enforcement matters and school code violations. This includes building(s), grounds, parking lot(s), lockers and other public school property. This will be performed by both physical presence as well as camera monitoring.
- C. To provide a classroom resource for legal education using approved materials as requested by the School District.
- D. To associate with students during the school day and be a positive role model.
- E. To be a resource for teachers, parents and students for conferences on School District grounds on an individual basis dealing with individual problems or questions, particularly in the area of substance control.
- F. To make appearances before school groups, parent groups, and other groups associated with the School District and as a speaker on a variety of requested topics, particularly drug and alcohol abuse. Additionally, serve as a resource to families that helps them connect to support services.

- G. To report and document all crimes originating on School District property. Information on cases that are worked off-campus by the Police Department or other agencies involving students on a campus served by an SRO will be provided to the SRO, but the SRO will not normally be actively involved in off-campus investigation(s).
- H. Any school code violations observed by the SRO shall be immediately referred to the School District. The SRO shall not discipline students, and the SRO responsibility for school code violations is limited to reporting said violations.
- I. To document activities performed for the School District and to provide said documentation in the form of a monthly report to the Police Department and to School District.
- J. To share information, complying first with Police Department protocol, with designated School District employees regarding individuals or conditions that pertain to School District safety concerns.
- K. To work with School District employees to develop plans and strategies to prevent and/or minimize dangerous situations which might result in student unrest.
- L. To coordinate his or her activities with designated School District employees and seek permission, guidance, or advice prior to enacting any programs within the school.
- M. To coordinate and/or present programs on law enforcement matters effecting minors as requested by the School District.
- N. To wear approved department regulation uniform and to carry on his or her person a department authorized duty weapons (firearm) in accordance with Police Department policy.
- O. Support mentoring programs including Forging Families and O'Huddle.
- P. Perform wellness checks for students and/or families when attendance or other concerns are known.
- 6. **Chain of Command.** As an employee of the Village, the SRO shall be subject to the chain of command of the Police Department. However, in performance of his or her duties, the SRO shall coordinate and communicate with designated School District employees of the School District.

7. Transporting Students

- A. The SRO shall not transport students in a Police Department vehicle except as follows:
 - (1) When a student is a victim of a crime, under arrest, or some other emergency circumstance exists; or

(2) A student is directed to leave the School District grounds pursuant to school disciplinary actions, and the student's parent or guardian has refused or is unable to pick up the child within a reasonable time period and the student is disruptive/disorderly and his/her continued presence on campus is a threat to the safety and welfare of other students and school

personnel.

B. A student who is removed from the School District grounds by the SRO should be transported to a law enforcement office or the location where the student's parent

or legal guardian is expected to be located.

C. The SRO shall not transport students in his or her personal vehicle.

D. No student should be removed from the School District grounds without first receiving approval from the School District or the SRO superior at the Police

Department.

8. Access to Education Records.

A. School District employees shall allow the SRO to inspect and copy any public

records maintained by the School District to the extent allowed by law.

B. If some information in a student's record is needed in an emergency to protect the health or safety of the student or other individuals, school officials shall disclose to the SRO that information which is needed to respond to the emergency

situation based on the seriousness of the threat to someone's health or safety; the need of the information to meet the emergency situation and the extent to which

time is of the essence.

C. If confidential student record information is needed by an SRO, but no emergency

situation exists, the information may be released only as allowed by law.
